I represent, confirm and certify to American Airlines that the two individuals named above are either married or spousal equivalents/domestic partners. Spousal equivalents/domestic partners means two adults who have chosen to share their lives in an intimate and committed relationship, reside together, and share a mutual obligation of support for the basic necessities of life.

Specifically, if relying on spousal equivalency/domestic partner, I declare and acknowledge that my spousal equivalent/domestic partner, named above, and I meet the following criteria:

1. We reside together and intend to do so indefinitely.
2. If applicable, we are not related by blood to a degree of closeness that would prohibit legal marriage.
3. We are mutually responsible for basic living expenses.
4. We both meet the minimum age of consent requirements in the state in which we reside.
5. Neither of us is married to anyone else.

I acknowledge that:

1. If requested, I will provide to American Airlines additional documents establishing the existence of my marriage/spousal equivalency/domestic partner relationship.
2. I would be well advised to consult an attorney regarding the possibility that the filing of this certification may have certain legal consequences, including the fact that it may, in the event of termination of the spousal equivalent/domestic partner relationship, be regarded as a factor leading a court to treat the relationship as the equivalent of marriage for the purpose of establishing and dividing community property or for ordering payment of monetary support.
3. I have an obligation to notify American Airlines within 30 days after an event such as a legal separation or divorce or, with respect to spousal equivalency/domestic partner, any event that results in my no longer meeting the above criteria.
4. I cannot make an alternative certification of spousal equivalency/domestic partner for a new spousal equivalent until at least 12 months after American Airlines is notified of termination of the previous spousal equivalency/domestic partner relationship.
5. American Airlines may rely on this certification for all purposes.
