

## **Brussels Airport Incident - Travel Notice Exception Policy**

This important notification is to inform our travel partners of special exception policies available for our mutual customers due to the situation in Brussels.

Our Travel Notice exception policies on American are also available when ticketed to/from/through on our Joint Business partners. This applies to both prime and codeshare flights as shown below:
